



2008 Wild Ones Photo Entry Form and Rules

Wild Ones' annual photo contest gives members a chance to show off their best native plant and landscape photos. Members are encouraged to experience the natural world and have fun. The emphasis should be on showing native plants and natural landscapes, and those things related to these environments. All members are encouraged to enter. A special category for kids persuades children, up to age 18, to show us their views of natural landscapes.

The photos will be judged initially on technical merit by a highly qualified photographer and then be on display at the annual meeting and conference the following day for further judging of the People's Choice award by conference attendees. Awards will be presented at the August 23, 2008 banquet. You need not attend the conference to enter the photo contest or win.

Only Wild Ones members and employees of our business members, whose membership is, and will be, current during the course of this contest may enter. Household memberships includes those who live within the same household. Deadline for receipt of mailed submissions is *August 18, 2008*—no exceptions. Photo contest entries personally delivered to the conference should be at the conference site in place no later than 4:00 PM on *August 22*. The committee reserves the right to reject submitted photos that do not adhere to the rules or that are inappropriate.

2008 Photo Contest Rules

Read and follow these rules carefully.

1. The subject of all entries must be native plant species, native species landscape, or native plant ecology found in the USA or Canada. Photos of subjects that are not native will not be accepted.
2. No more than two entries per category and no more than four entries per member (each person under a household or business membership may enter).
3. Photos cannot have been previously entered in the Wild Ones Photo Contest.
4. All photos must be at least 5 x 7" and no larger than 11 x 14"
5. Photos may be in color or black and white.
6. Each photo must be securely mounted on mounting board. (Available through most photo shops and art supply stores.) Matting and framing is optional.
7. A completed entry form must be affixed to the back of each entry. Entry forms may be photocopied.
8. Photographs will be judged according to the following criteria:
 - a. Technical merit (composition, sharpness, exposure, color)
 - b. Appropriateness to category
 - c. Presentation (neatness of mounting)
9. Photographs may not be removed after the conference unless an electronic file has been provided with the entry. It is preferred that you include a CD with the photo files with your entry. See the guidelines section below.

Categories

All photos must contain images of native plant species.

- **Flora:** Plant species native to the United States or Canada.
- **Scenery:** Any aspect of native woodland, savanna, prairie, and wetlands (may include wildlife as part of the native landscape).
- **Pollinators, Insects or Bugs:** Native to the United States or Canada.
- **Child or Children:** Exploring the natural environment (prairies, woodlands, or wet areas made up of native plant species).
- **Residential Landscaping:** Native landscaping that includes residences as part of the subject.
- **Non-residential Landscaping:** Native landscaping that includes non-residential buildings or recreational areas as part of the subject.
- **Wild Ones Activities:** Educational programs (monthly meetings, conferences, seed exchanges, seed collecting, garden tours, etc.) public relations activities (home & garden shows, festivals etc.) and plant rescues.
- **Kid's Photos:** Photos in any of the above categories taken by children up to age 18. All entries are judged as one category under the Kid's Photos category no matter what the descriptive category from above is. Kids can enter up to four photos but no more than two entries from any of the above categories. For example, two might be of the category of Flora, one of Landscaping and one of Scenery.

Guidelines

The following gives you additional information as you consider your entries.

When viewing photographs judges look for impact, creativity, composition, center of interest, lighting, color balance, and print quality. If a photo captures all this but is not sharp, it loses all these elements—above all, a print *must* be sharp.

If matting is used to compliment a photo, it must be cut neatly and the color of the matt must compliment the photo. Photos must be mounted and trimmed neatly on a mounting (art) board or Foam Core™. Use a quality photo adhesive or equivalent adhesive to secure the photo to the board. If not done appropriately, any of these elements will detract from the photo rather than enhance it.

The Process:

Photos will be judged twice. The first round of judging will be by a highly qualified photographer who will determine a first, second, and third place award in each category. The second judging round will be by annual meeting or conference attendees who will determine the People's Choice award.

We will be using the photo entries in our promotional materials and a slide presentation of the winning entries. Therefore, photo entries can be picked up following the conference **only** if an electronic file is provided of the entries along with a copy of each entry form. Resolution for these files should be no less than 300 dpi and saved in either .jpg, .psd or .gif format. **Entries will be returned by mail only if accompanied by self-addressed, postage paid packaging. We are not responsible for damage or loss.**
